**Winter uniform, including the school tie (Years 1-6), should be worn every day during terms 1b, 2a and 2b, and summer uniform for terms 1a, 3a and 3b. All pupils should wear PE kit on their PE days.**

**Children are only able to participate in PE/games with the appropriate clothing. At certain times of the year, pupils may be asked to have a second pair of shoes for PE days.**

## Trainers for PE

Plain, sturdy trainers are important for PE lessons as pupils participate in a range of sporting activities. At Rush Common, we appreciate the importance of good footwear. With this in mind, we recognise that trainers do come in a range of styles. Whilst it may be difficult to find affordable, plain trainers that are good quality, please bear in mind that trainers:

- should not be brightly coloured.
- should be a majority black, navy or white.
- 

In addition to this, other aspects of our agreed uniform are as follows:

- Children should come to school with a warm, waterproof coat. Waterproof coats with the school emblem are available to purchase from the School Uniform Shop. Hats, gloves and scarves of any colour may be worn.
- In inclement weather children should have an appropriate, waterproof coat in school, even in warmer months.
- Shoulder-length or longer hair should be tied back using a scrunchie, hair band, clip or ribbon that is black, brown or green. No large bows or brightly coloured hair accessories.
- Unnatural hair colouring, extreme shaved hairstyles and hair gelled styles are not permitted.

‘Unnatural’ means:

- A colour that is not found in the natural hair colour spectrum (i.e. bright, extreme or vivid colour)
- A combination of colours that is easily visible or in stark contrast

‘Extreme Shaved’ means:

- 0/1 clipper grade
- Shaved tramlines/designs
- Minimal jewellery should be worn for practical, health and safety reasons. A wristwatch and/or single stud earring in each ear lobe are permitted. All jewellery should be removed for PE and games.
- In summer months, shorts underneath dresses/skirts provide comfort and allow for greater movement when playing on the field at break times.
- Smartwatches that can connect to phones or record are not permitted. A step tracker (i.e. Fitbit) is permitted as long as it does not connect to another device.
- Nail varnish, temporary tattoos and make-up should not be worn in school.

## Cost of Uniform

We want to ensure that the cost of uniform does not lead to children feeling socially excluded or families unable to afford other necessities. Parents/carers who are unable to provide a uniform for their child should contact the Headteacher where approaches will be handled sensitively and with discretion.

The uniform supplier, quality and costs are reviewed to ensure that the school provides good quality clothing at an affordable price. Friends of Rush Common (FoRC) also hold regular second-hand uniform sales throughout the school year, and they are contactable throughout the school year.

## Expectations for the school community

### Pupils

- Pupils are expected to wear their uniform smartly at all times. This includes:
  - keeping shirts tucked in
  - not wearing sweaters or cardigans around their waist

### Parents

- Parents/carers are expected to ensure their child has the correct uniform and PE kit that are:
  - clearly labelled with the child’s name
  - clean and presentable
- For cases where uniform may vary for an extenuating circumstance (i.e. outgrown shoes), parents should email the school office and address the issue as soon as possible.

### Staff

- Staff will closely monitor pupils to make sure they are in correct uniform; support staff will notify class teachers.
- Staff do not address uniform issues with children but instead inform the Operations Manager who will email the parents concerned. See section 4 below.
- Reminders to tuck in shirts will be given to pupils.

## Enforcement of the Uniform

It is the responsibility of parents to ensure their child comes to school in the correct uniform (see Home School Agreement). All staff have a responsibility for ensuring that children are correctly dressed in class and elsewhere on the school site. In the first instance we will email parents outlining the changes in uniform required. In the event of repeated infringements, parents/carers will be required to meet with the Headteacher. In the case of accessories, the child will be asked to remove the item(s), which may be confiscated until the end of the school day.

The Headteacher is the final arbiter in all matters of uniform and dress.

## Issues Arising from the Policy

Parents should raise any issues related to the school uniform or aspects of appearance with the Headteacher. Requests to vary the uniform requirements for particular reasons (such as medical needs), will be carefully considered on an individual basis.

Children should raise any uniform issues with their class teacher; they may also request that uniform matters (including proposals for change) be put onto the agenda of School Parliament meetings.

## Disability Discrimination Statement

It is unlawful to discriminate against disabled pupils. A person is considered disabled if they have a mental or physical impairment which has a substantial and long-term adverse effect on their ability to carry out normal day-to-day activities. A school discriminates if:

- it treats a disabled pupil or prospective pupil less favourably than another for a reason related to their disability and without justification.
- it fails, without justification to make reasonable adjustments which require the school to think ahead, anticipate the barriers disabled pupils may face and remove them before a disabled pupil is placed at a substantial disadvantage.

With regards to the uniform policy, the school will make reasonable adjustments and adaptations as necessary to ensure the best support for pupils with a disability.

Rush Common School will respect variations to the school uniform if they are directly related to a pupil's protected characteristic. However, any variation will be dealt with on an individual basis and judgements will remain at the discretion of the Headteacher.
